Council Member Goldstein discloses that he is a member of the Cobb NAACP. Council Member Goldstein discloses that he is on the board of the Marietta Welcome Center representing the City of Marietta.

Council member Goldstein stepped down for the part of the discussion related to the Earl Smith Strand Theatre and the GA Metro Dance Theatre.

Discussion was held regarding the grant amounts that would be awarded to each tourism organization. Chairman Kelly presented the following recommended amounts:

The Earl Smith Strand Theatre - \$54,500 Friends of Brown Park - \$4,000 Cobb NAACP Juneteenth - \$10,000 GA Metro Dance Theatre - \$18,000 Georgia Symphony Orchestra - \$15,000 Marietta/Cobb Museum of Art - \$85,000 Marietta Museum of History - \$157,000 Marietta Square Branding Project - \$24,000
Old Zion Heritage Museum - \$10,000
The Georgia Ballet - \$3,000
Marietta Gone with the Wind Museum - \$57,000
City Staff Request-City Services-Vapor Wake Dog Included - \$96,337
Marietta Business Association (Art in the Park) - \$16,666
Marietta Welcome Center - \$270,000
City Marketing Budget for Museums, etc. - \$24,500
