Glover Park Brewery Special Use Exception

From the J/L minutes the 8/28/18 J/L Committee Action a special use exception for Glover Park Brewery, located on Atlanta St., extending Food Truck hours beyond sunset to 10 PM pursuant to sub paragraph (k) of Food Truck Ordinance. Said Special Called Meeting Action effective immediately upon passing with expiration of said special use being the end of term of current council. (January 2022).

City Attorney Doug Haynie opened the public hearing and called forward those wishing to speak.

Melinda Burnett, who resides in the Meeting Park subdivision, spoke regarding this matter.

In depth discussion was held regarding the wall/fence separating the brewery from the Meeting Park pool area. Discussion was also held regarding the noise that may travel from the food trucks into the neighborhood.

Motion to approve a special use exception for Glover Park Brewery, located on Atlanta St., extending Food Truck hours beyond sunset to 10 PM, Thursday – Sunday, pursuant to sub paragraph (k) of Food Truck Ordinance. Said Special Called Meeting Action effective immediately upon passing with expiration of said special use being the end of term of current council. (January 2022).
