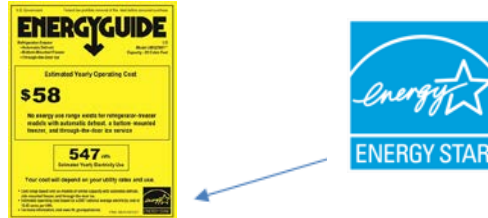

Conditions and Requirements

- The equipment/appliance must be installed in a permanent, single-family residence **receiving permanent electrical service from Marietta Power and Water.**
- All appliances must be Energy STAR Certified. An original original Energy Guide tag must be submitted for each appliance. **The Energy Guide should include the ENERGY STAR logo as shown here. Energy Guides without the ENERGY STAR logo indicate the appliance is not ENERGY STAR certified; therefore, those appliances do not qualify for this rebate offer.**



- Only one item in each category will qualify for rebate. (i.e. If you purchase two refrigerators, you only receive a rebate for one; if you purchase one refrigerator and one dishwasher, you will receive a rebate for both). Only one rebate will be accepted for each category per customer and location during the life of the rebate program.
- Original receipt(s) and energy guide tag(s) along with this completed application must be submitted within 60 days of purchase. Original receipt must clearly indicate date of purchase, brand and model for each item submitted. Please allow eight weeks for credit to be applied to your Marietta Power and Water utility bill.
- Customer is responsible for securing contractor(s) for HVAC improvements.
- A representative of Marietta Power and Water will verify installation.
- Energy Star rebates cannot be combined with other Marietta Power and Water rebates.
- Rebate program is subject to funding limitations and may end at any time without notice.

I hereby certify that the equipment/appliances/improvements listed above have been installed at the address listed and I will allow a representative of Marietta Power and Water to physically inspect my residence. I certify by my signature below that I will comply with all of the requirements of the rebate program, and further acknowledge that providing any false information may subject me to criminal penalties under O.C.G.A. § 16-10-20 up to and including a fine of \$1000 and imprisonment for five years.
