Proposed Code Amendment to the Floodplain Management/Flood Damage Prevention Ordinance

The revision concerns section 7-8-10-050 (B) (5) (b) (2) by deleting the word "either" in #band deleting option #2. The remainder of the ordinance will remain unchanged.
