The City of Marietta is advertising a proposed Substantial Amendment to its CDBG Annual Action Plan. The proposed PY2021 Annual Action Plan Amendment includes: reallocation of \$5,861.53 in unexpended PY2020 Administration and Planning funds that are being reallocated to PY2021 ELD Emergency Grants.

The proposed PY2020 Annual Action Plan Amendment includes: reallocation of CDBG-CV funds in the amount of \$8,008.98. The amendment proposes that \$8,008.98 will be reallocated from Public Facilities-CV projects to The Salvation Army's Emergency Rental Assistance-CV project.
