Upon motion of Councilman Eugene Holcomb, seconded by Councilman S. J. Lindsey, it was moved and carried that the following Ordinance be and the same was adopted.

ORDINANCE NO. 1307

An ordinance declaring the policy and purpose of the City of Marietta, Georgia to extend to the employees and officials of said city or town and its instrumentalities, not excluded by law or by this ordinance, the benefits of the systems of Federal Old Age and Survivors Insurance, as authorized by the Federal Social Security Act, and amendments thereto, and as provided for in Act No. 734, Georgia Laws 1953, approved December 21, 1953, upon the basis of applicable State and Federal Laws or regulations; authorizing and directing the Mayor, or other chief executive officer, to execute agreements and amendments thereto with the Employees' Retirement System of Georgia, for coverage of said employees and officials of said City shall appropriate and pay over for employer's contributions, administrative expenses, and a guaranty fund as provided by applicable State or Federal Laws or regulations; providing that said City shall keep records and make reports as required by applicable State or Federal Laws or regulations; excluding from this ordinance any position, employee or official not authorized to be covered under applicable State or Federal laws or regulations.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARIETTA, GEORGIA, as follows:

Section 1. It is hereby declared to be the policy and purpose of the city of Marietta, Georgia, to extend at the earliest date possible under the agreement entered into by the State of Georgia and the Federal Security Administrator, to the employees and officials thereof, and its instrumentalities, not excluded by law or by this ordinance, the benefits of the System of Old Age and Survivors Insurance as authorized by the Federal Social Security Act and amendments thereto, including Public Law 734 of the 81st Congress, and as provided for in Act No. 734, Georgia Laws 1953, approved December 21, 1953, In pursuance of said policy, and for that purpose, the city shall take such action as may be required by applicable State or Federal Laws or regulations.

Section 2. The Mayor, or other chief executive officer, of the City of Marietta, Georgia, is hereby authorized and directed to execute all necessary agreements and amendments thereto with the Employees' Retirement System of Georgia and officials as provided for in Section 1 hereof.

Section 3. Withholding from salaries or wages of employees and officials for the purpose provided for in Section 1 hereof are hereby authorized to be made in the amounts and at such times as may be required by applicable State or Federal Laws or regulations, and shall be paid over to the State Agency.

Section 4. There shall be appropriated from the Social Security funds such amounts at such times as may be required by applicable State or Federal Laws or regulations for employer's contributions, administrative expenses, and a guaranty fund to assure that the State will not incur any debt or loss as a result of the agreement referred to in Section 2 of this ordinance. Such funds shall be paid over the employees' Retirement System of Georgia in accordance with regulations established by said Agency.

Section 5. The City shall keep such records and make such reports as may be required by applicable State or Federal Laws or regulations.

Section 6. There is hereby excluded from this ordinance any authority to make any agreement with respect to any position, or any employee or official not authorized to be covered by applicable State or Federal Laws or regulations.

Section 7. This ordinance shall take effect upon its approval and publication as required by law.
