has been completed no further action required in this fiscal year (Page 263), Retrofit existing dams using Cobb County's Storage Volume Purchase Program to create freeboard ...completed no further action required in this fiscal year (Page 264), Perform field surveying including dams, spillways, downstream cross section and downstream has been completed no further action required in this fiscal year (Page 264)structures within dam breach zone

4. Discuss why any objectives were not reached or why implementation is behind schedule: *Form workgroups to assess mitigation strategies for high flood risk areas task was deferred due to lack of personnel, and for Marietta high turnover in the stormwater related position. This position has now been filled for the past 6 months and we look forward to working with Cobb County should a workgroup be reconvened. Conduct assessments for widening stream buffers this project was deferred by Cobb County due to lack of stakeholder traction. Currently Marietta is experiencing infill development and almost no development of raw land. As such political and market forces would not be conducive to greater buffers. Currently Marietta extends the State undisturbed buffer to 50' City undisturbed and an additional 25' (75' from point of wrested vegetation) no impervious setback. With many of our infill lots being less than 0.1 acres such buffers are already approaching being a taking.*
