City of Marietta Parks, Recreation, and Facilities Sprayground General Information

Hours of Operation

- Weather permitting, the sprayground will be operational from early May thru the end of September. Operating times are dependent on weekly weather forecasts.
- The regular operating season will run from Memorial Day until Labor Day
- The sprayground is open daily, except Mondays. On Mondays, the facility is closed for routine maintenance and for private rentals.
- Hours of operation are from Tuesday thru Sunday, 10:00am – 8:00pm.
- Occupancy is maxed at 170 people within the sprayground area (including pavilion).

Admission

- Daily Admission is \$2 per City of Marietta resident, \$3 per Non-Resident.
- \$30 Individual Season Pass, \$60 Family Season Pass for City of Marietta Residents Only, up to 4 family members & \$15 each additional family member.
- \$45 Individual Season Pass, \$75 Family Season Pass for Non-Residents Only, up to 4 family members & \$18 each additional family member.
- Passes are good for the calendar year April thru September.
- Cash and major credit/debit cards are accepted.

General Information

- All persons using the sprayground do so at their own risk.
- Children under 12 years old MUST be supervised by someone 16yrs of age or older.
- Visitors wishing to leave and return (on the same day) will be readmitted with a wristband, dependent on occupancy limits. Management reserves the right to establish time limits on daily admissions if needed.
- The water is chlorinated and recirculated through a filtration system.
- Private rentals of the facility will be available on Mondays 10:00am – 8:00pm
- Strollers and car seats cannot be in the spray area and must be parked or placed outside the spray area.

Wristbands

- Wristbands are purchased at the concession stand and must be worn to enter the sprayground. All children must wear their wristband on their wrist, ankle, or swimsuit – no exceptions. Adults must wear their wristbands on the wrists.
- Wristbands are good for the entire day. Customers can leave and return as many times as they like in the same day (occupancy limits and/or time limits may prevent re-entry).
- 2hr pavilion parties will have a different color wristband and are good only for the rental period. Re-entry will require the purchase of a day use wrist band.

Swim Diapers

- All children under the age of 3 years (or older children requiring them) must wear a swim diaper AND a vinyl cover. Swim diapers are required upon entry and must be shown to attendant. This is for the safety of our patrons and to avoid fecal contaminants and shutdowns. No changing diapers allowed outside of the restrooms. There are changing tables in each of the four restrooms. There is also a family restroom located inside the sprayground gate located next to the concession stand. Please help keep the sprayground open (a biological incident can close the sprayground for up to 4 hours).

No Food – Drinks – Toys

- No toys, food, bottles or drinks allowed in the spray area.
- All food, coolers, and drinks are to be kept on the hardscape areas of the pavilion/concession areas. No food shall be near the water to prevent chemical imbalance and filter clogs.
- Coolers of any kind are only allowed in the pavilion area during paid rentals. All other times they are prohibited.
- Staff reserve the right to check bags for food brought into the spray area.
- Toys on the sprayground or deck are a trip hazard and can be dangerous, as well as break and get into the pipes and filtration system.
